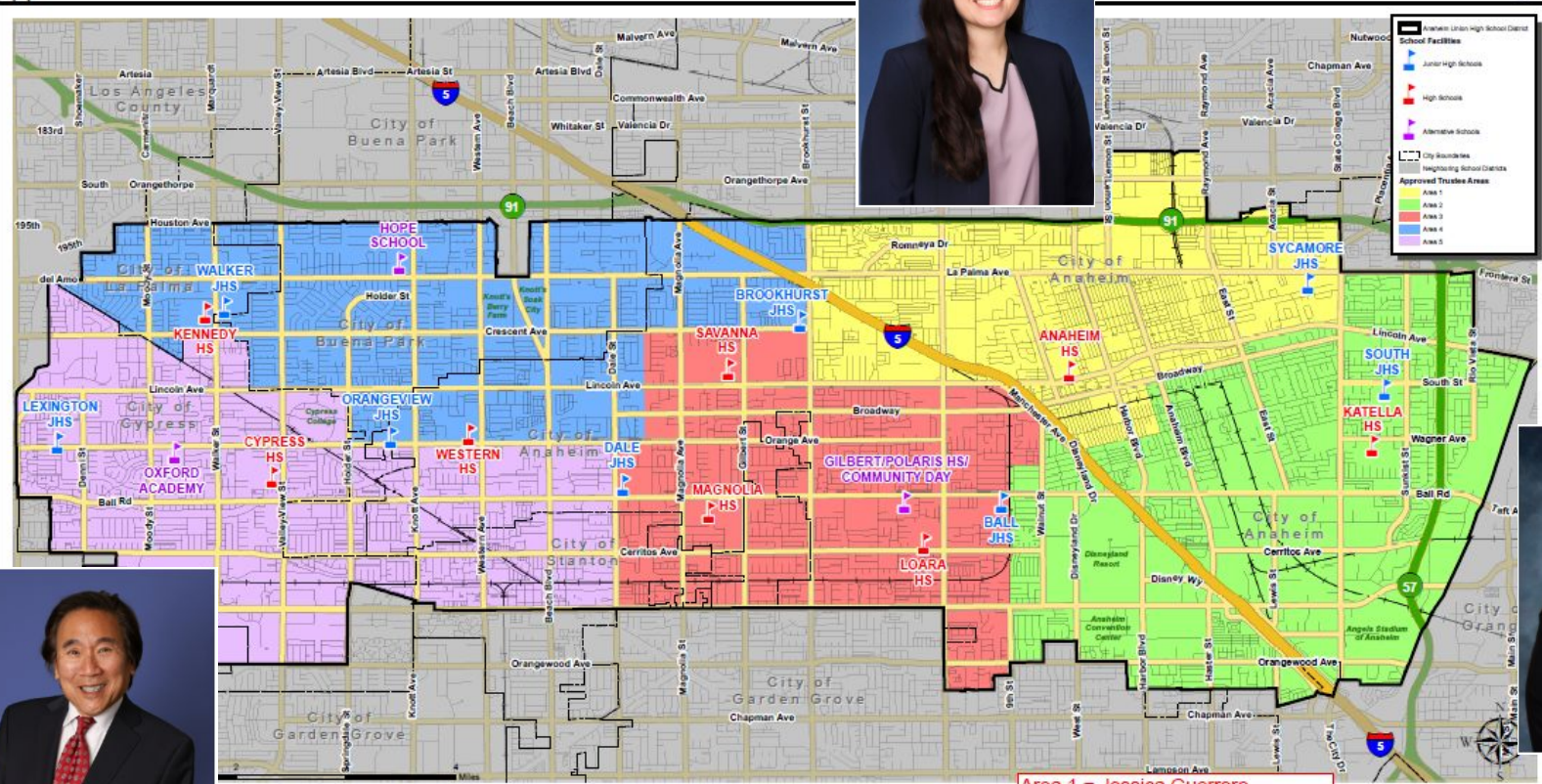

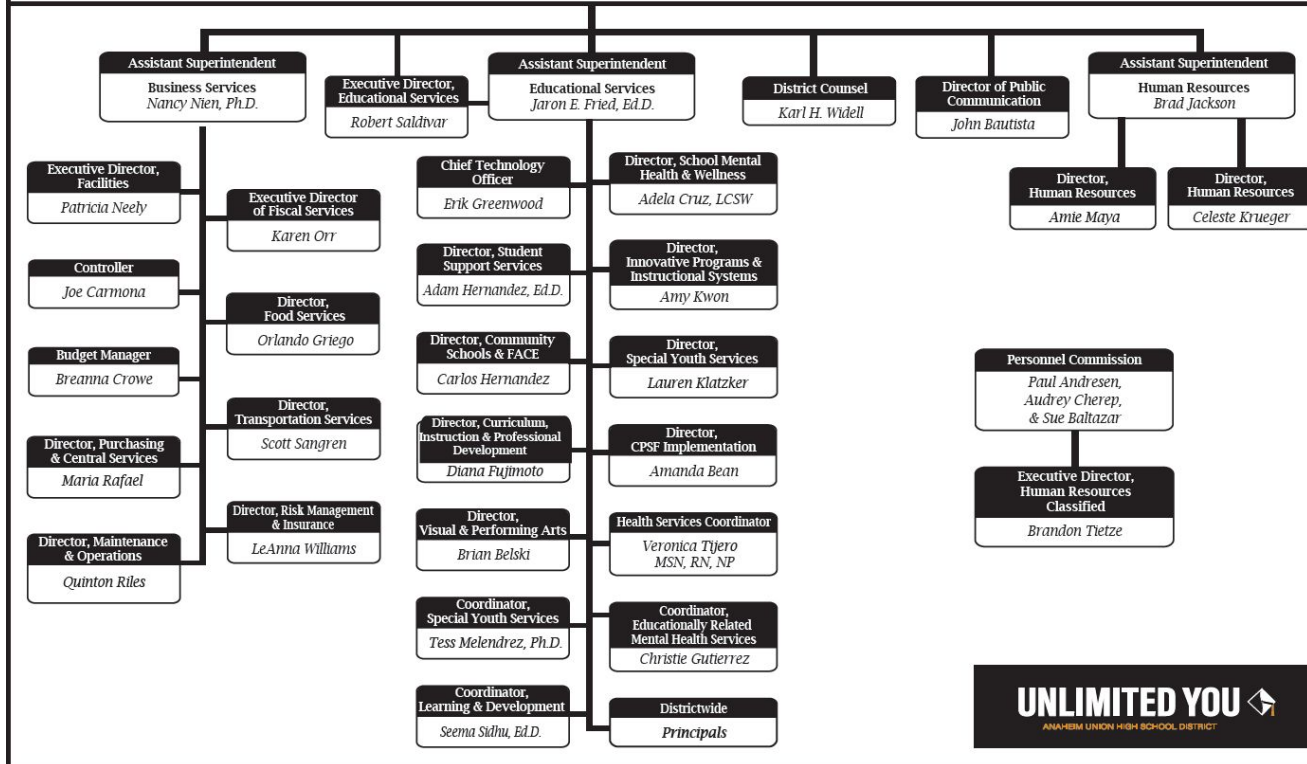

Board Composition and Terms

The Board is composed of five elected Trustees and one student representative.

- Each Trustee represents a unique geographic Area of approximately equal population that is reapportioned every 10 years based on the census.
- Trustees serve staggered four-year terms.
- The current appointment is for Area 3.
- Although the Area 3 term runs from 2024-2028, a provisional appointee must stand for election at the next election cycle in 2026.

Board Officers and Meetings

The Board conducts an organizational meeting every December.

- Trustees select a President, Clerk, and Assistant Clerk for the coming year.
- The meeting calendar is confirmed, including at least one meeting per month, usually on a Thursday.
- Trustees also appoint a Secretary (the Superintendent), Chief Negotiator (the Assistant Superintendent of Human Resources), and Parliamentarian (Counsel).
- Trustees choose committees and other assignments.

Brown Act

The Board's meetings are governed by the Brown Act.

- All business must be conducted in a session open to the public, unless there is an exception.
- Regular open session meetings start at 6:00 p.m.
- The Brown Act permits limited exceptions for **confidential** closed session discussions.
- Closed sessions often start around 3:30 p.m. but may be earlier depending on business.
- All Board business must be on an agenda.
- Trustees receive Brown Act training from CSBA.

Board Action

The Board acts by majority vote.

- The Board sets the direction and policy for the District.
- The Board hires the Superintendent to manage the day-to-day operations of the school district.
- Individual Trustees do not have administrative authority and cannot resolve complaints on their own.

Additional Trustee Responsibilities

- Trustees must identify and disclose conflicts of interest pursuant to the adopted Conflict of Interest Code, Board Policy 6203.01 (9270).
- Trustee communications are subject to the California Public Records Act (Government Code).
- Trustees are mandated reporters under the Child Abuse and Neglect Reporting Act (Penal Code).

Summary: Function of the Board

- Represents the constituents of the District
- Hires and supports the Superintendent
- Gives collective direction to the Superintendent
- Sets District policy
- Approves educational objectives and oversight
- Ensures a safe working and learning environment
- Maintains a fiscally responsible budget

Summary: A Board Member Does Not

- Perform management functions
- Give direction to employees
- Ask an employee for information that requires research
- Consume an employee's time through an extended conversation that is not pertinent to the District
- Make promises (it takes 3 Board Members to direct the Superintendent)
